In Sub-Saharan Africa, Internews trained thousands of journalists about how to report effectively on health issues, including HIV/AIDS, maternal and child health, malaria, TB, and family planning. In our health journalism work in Kenya, we focus on making sure that people have the information they need to protect their health - and that the media environment supports affected populations, rather than stigmatizing them. We respond to emergency situations - such as the Ebola outbreak in West Africa - by tracking and countering harmful rumors and misinformation. And we use cutting edge data journalism techniques to increase Government accountability in providing health services.
